

Minutes for COUNCIL MEETING of McMaster University Retirees Association **Wednesday January 13, 2010**, 1:30 PM at the Student Centre Rm 224.

1. Welcome & Regrets:

Joan Parker called the meeting to order at 1:30 PM... She welcomed Stefania Miller to Council.

2. Minutes of Previous Meeting:

Council meeting minutes for December 9, 2009 for approval.

Moved by Helen Barton; and **seconded** by Kathy Overholt that the provisional minutes be adopted as corrected. **Motion carried.**

3. Business Arising

(a) Update on academic awards and endowment fund raising campaign (Beth Csordas)

As of Jan 13, the scholarship endowment had achieved \$35,283, \$3,283 above its original objective of \$32,000. The revised goal for this endowment is \$40,000. It is hoped that this can be achieved by the 2010 Annual General Meeting (AGM).

(b) Update -2010 – 25th MURA Anniversary (Mike Hedden)

Mike Hedden talked to Andrea Farquhar who is Director of Public and Government Relations re a logo to help celebrate MURA's 25th anniversary. The McMaster Coat of Arms can be used in a holistic pattern as we do with our current letterheads, but disassembled parts of the crest cannot be employed. This needs to be emphasized when we seek input to the logo design. Andrea and cohorts can help with a design if that is needed. She would like a copy of the assemblage of 25 facts about MURA. There is still some doubt about minor details with respect to successive presidents of MURA. Mike also has been in touch with Dorothy Jacobs regarding historical photos of MURA personnel and

activities. and has also contacted Jane Christmas in Public Relations to see if the University had any then-and-now photos.

(c) Confidential Report on Supplementary Pension Benefits for Clinical Faculty

(Helen Barton/Les Robb)

Joan Parker recently received an email from Roger Couldrey, the Interim Vicepresident of Administration, saying that he will need a two week grace period prior to replying with respect to this ongoing problem.

4. Correspondence (Joan Parker)

- (a) Joan received an e-mail from CURAC's Secretary, George Brandie with an invitation to MURA representatives to the CURAC AGM to make a presentation on one of two themes. This has been forwarded to Marianne Van der Wel, Marianne Walters and Helen Barton, who may be attending this conference.
- (b) Joan received an e-mail from Waterloo Insurance requesting that a brochure be sent out with the next mailing of MURAnews. After discussion Council agreed that we should limit mailings of their brochure to two/year and that this can be accompanied by a box-blurb referring to the insurance opportunies in MURAnews

5. President's Report (Joan Parker)

- (a) Eleanor Gow has agreed to audit MURA finances this year but it is noted that this will be her last year as auditor. **Moved** by Helen Barton; and **seconded** by Marianne Van der Wel that we appoint Eleanor Gow to audit MURA's books and report at the 2010 Annual General Meeting (AGM). **Motion carried** unanimously.
- (b) With respect to the **Update -Should MURA be facilitating paid employment positions via MURAmembs-l. The Union Position,** Joan Parker wrote a short letter to Annette Branch, Manager of the Employment Centre on Jan 1, 2010 seeking her recommendation re this item as it relates to MURA's activities in pursuing volunteer help via MURAmembs-l.
- (c) Joan wrote a letter to Peter George requesting support from the University for next year's Christmas luncheon. This letter got shifted through the bureaucracy but ultimately awaits a response from the President that is still pending.

6. Treasurer's Report: (Beth Csordas)

Beth summarized the finances for the 1009 Christmas luncheon. Net \$ outflow was \$724.76. MURA budgeted for \$635.76. Shortfall is \$89.76.

7. Information Reports from Committees

(a) Christmas Luncheon Report (Pam Penny/Joan Parker)

As noted above, Joan contacted the President's Office on January 11, 2010 seeking to institute financial support for the 2010 Christmas luncheon. Pam Penny has booked next year's luncheon for Celebration Hall for Dec. 6, 2010.

(b) AGM (Pam Penny)

The preferred date for AGM 2010 is Wednesday May 26. Pam Penny has booked Celebration Hall for that date. Joe Laposa has been seeking potential speakers for the AGM Neither Chuck Johnston nor John Weaver is able to undertake this commitment. After some discussion Council agreed that we should seek Alvin Lee to speak to the changes in McMaster in the past 25 years with Les King and Ken Cruickshank as alternatives.

(h) **Pensions and Benefits** (Marianne Walters)

Marianne reported on her efforts to find out if the retirees' once-in-a-lifetime \$ 10,000 Sun Life Insurance for emergency medical services out of province or country can be used to pay the deductible on other out-of-province/country emergency medical insurance. It has proved very difficult for her to discover just what the Sun Life Insurance is applicable to, with mixed messages from various health insurance and university sources. She will continue in attempting to clarify the situation and will report back to council.
