**4.3 MUFA Newsletter article on Pensions in Ontario (Cliff Andrews and Bob West)**

The report to appear in the winter MURAnews combines a number of sources on the proposed amalgamation of the assets public and university pension plans in Ontario, with a summary of the history behind this initiative, the possible benefits and the inevitable difficulties in instituting the legislation. Right now, the legislation is in limbo, because the provincial government is in a state of prorogue. Bob West and Cliff Andrews utilized the Morneau report as the basis for their article in MURAnews... The initiative should allow a province-wide plan, with good investment dealers, to invest in attractive investments that no individual university fund is able to do. Such plans are now in operation in other provinces such as British Columbia and Alberta. The pooling of investment funding would not change the status of individual university plans in terms of shortfall in their pension plans. Thus, it is forward looking, but does not change responsibility of current pension shortfalls. To date, the consultant report has addressed only the concept of investment pooling and not the future cost-share arrangements of such a program. After government reconvenes the likely time line for legislation to ensue is two to three years.

**5.1 Correspondence with Economical Select**

Their inserts will be available for stuffing (electronic and regular mail) with the winter MURAnews. Economical Select raised the possibility of sending snail mail brochures to the MURA electronic mailing list through the known MURA address list.
