#### 5. Reports from Committees

##### 5.1 Volunteering (Betty Ann Levy)

This month the committee focused on developing MURA's partnership with the Discovery Program. It is a community outreach program that offers a course to adults who have an interest in learning but who are not able (financially or academic background) to attend regular courses. Some of the people who have completed the program are now interested in further opportunities to learn at McMaster. Discovery has no budget for this and President Deane correctly hesitates to use funds from the academic budget that are needed for regularly registered students.

Back in March, Betty Ann arranged a speaker to address about 20 of these students. It was a great success and the leaders of the Discovery Program would like it to continue it with MURA taking a prominent role in arranging lectures, facilities tours or workshops and providing snacks and (non-alcoholic) beverages. Discovery has set up an on-line site for fundraising and have asked if we could help to advertise it. The estimated cost per year would be about \$1000.

Les King mentioned that he is involved with the Hamilton Third Age Learning program. He suggested that this group may be interested in supporting this Discovery extension program through MURA. He will pursue this idea with HTAL and report back at the June meeting.

Council members agreed that we support MURA’s participation in the program with the funding to be discussed in June.
