#### 3. President's Comments (Les King)

Les reported that he and his wife will be representing MURA at the Convocation Dinner

Les and Peter Sutherland have a meeting with the Acting Director of Parking tomorrow morning (June 11) to discuss the issue of the upcoming Parking Transponder upgrade. There is a particular concern about the flow of information to retirees. The email received by some MURA members mentioned new decals or transponders for assigned lots (not applicable to retirees). The meeting will focus on how the Parking Office plans to make the information available to retirees and how MURA may be able to help.

Another important university upgrade which will effect some retirees is the email migration from Univmail to MacMail. Heather and Helen have met with representatives from UTS to talk about when and how it will take place. They hope to recruit a small group of people who can act as a test group before the actual start.

### 5.1 Hourly Pension Committee (Cliff Andrews)

### 5.2 Salaried Pension Committee (Bob West)

Bob reported that for the 3 months ended March 31/15, the total fund return before expenses was 6.8%. The last quarter (April to June) results look rocky but will probably still be positive. The account managers choose and trade stocks regularly and have done a good job. Salaried staff will likely get an increase in January 2016.

There has been an amendment to the Plan which now requires the university President to join the faculty pension plan as he is considered to be a faculty member.

There has been some discussion by several universities about combining pension plans but nothing definite has been decided. McMaster would probably not be interested in such a move as there would be less flexibility.

**6. Other Business**

Bob West mentioned that MURA has a big pot of money in the bank but continues to take money from the three supporting groups. Council probably should consider either reducing our requests from the supporting groups or find some other way to reduce the pot. Les said that we should put our heads together to figure out how to spend some of our excess funds.

**ACTION ITEM:** Add an item to the agenda sometime in the Fall to discuss the issue of excess MURA funds sitting in the bank.
