2. Minutes of Previous Meeting

2.1 Council Meeting March 13, 2019 (for approval)

4. Human Resources Report (Alison Forler)

- Still working on the dispensing fees article for *MURAnews*
- Regarding the HR website review – there will be a focus group for retirees probably to be convened in May (update: May 10)
- Brian asked about progress on the definition of “retiree” – Alison said HR is still working on it
- The pension web modeller for current employees seems to be working well
- There are several more pre-retirement workshops scheduled – Alison will send dates
- There is a large number of retirements scheduled between now and July 1st – some are people who have just taken a pre-retirement workshop
- A large number of calls from retirees to HR was related to the change in address for mailed benefit claim forms

- In the search for a new Treasurer, Debbie Wiesensee has been suggested; Heather will ask her. If Debbie isn't interested, Heather will ask if she has any suggestions.
- Heather said she will be contacting new retirees about their transition to retirement.

7.1 Academic Awards Endowment (Beth Csordas) – written report

- Increases in the value of our awards are going for approval on April 16th.
- **Winn bursary**
 - A written report on the Academic Awards was circulated prior to the meeting. The report included an explanation by Karen McQuigge (from Alumni & Development) that the move to Mosaic has automated much of the process of awarding bursaries, which doesn't always ensure one student will receive a bursary from the Winn fund.
 - Les King said that we could ask if changing the bursary to a prize or scholarship is possible, and that Helen wants to fight to get the University to follow our specifications.

- Other suggestions Karen McQuigge made in the written report for MURA fundraising include initiatives around student food security, and student mental health programming – any monies raised would go into the operating budget.
- Les volunteered to talk to Ellen Ryan for other suggestions.
