Reserve for McMaster Graduate Scholarship Contribution

"that whereas MURA continues to fundraise for its \$25,000 Graduate Academic Scholarship fund, and whereas the fund has reached the halfway point, and whereas the association has generated extraordinary surpluses during COVID-19, that \$5000 be moved from Unrestricted Equity into a new reserve called Reserve for McMaster Graduate Scholarship Contribution in April 2022."

The reserve will have the following note in the year-end financial statements: This amount represents funds set aside in 2022 to contribute to the MURA Graduate Academic Scholarship Fund when the fund reaches \$22,000. \$3000 will top up the fund, and \$2000 will ensure that a \$1000 annual scholarship is awarded in each of the next two academic years.

 - There was a discussion about the labels used to describe the different groups in the membership report. For example, Parking has a few full timers, and the rest are students; Security employees are hourly. Up until now, Unifor members have been grouped together for funding purposes, but it would be useful to have them reorganized in a way that more closely reflects the relationship between the retiree groups and our funding partners.

- Brian followed up on the retiree who wanted a claim form for vision benefits and a change of beneficiary form, and sent her postal address to Michelle.
- Shingrix: Brian petitioned HR/Jordan Roberts about making exceptions for people who made claims for second shot after the January cutoff, but HR's

position was a hard no. However, Jordan said he would keep MURA in the loop about any advance notice he receives in future about the way benefits are administered. **Action**: Nora will keep a copy of the email where Jordan made that commitment.

 Brian noted that Sun Life pays out according to the benefit package, and at the end of the month they send the bill to McMaster and McMaster pays it, so the final decision on whether a claim is paid is McMaster's.

 - On Monday there was a meeting where there was a discussion concerning how to report carbon emissions in investments. The committee is in the midst of setting objectives for reductions in the number of tons of carbon emitted by companies we invest in per million dollars in sales. The bursary fund has a higher carbon footprint than the salaried pension plan. By September they hope to have a plan for what the reduction will be, with a goal to be at 0 by 2050.
