## PROPOSED CHANGES TO MURA CONSTITUTION

(Additions highlighted; deletions struck out)

### PURPOSE OF CHANGES-GENERAL

To revise membership definitions, for the purpose of clarification and ease of interpretation

To revise membership services and eliminate fees (as a result of the new funding agreements with MUFA, MUSA and the University)

To revise certain other clauses, for the purpose of clarification

### EXPLANATION OF PROPOSED AMENDMENTS

#### Article 2.01 – Objectives \_\_\_\_\_

The objectives of the Association are:

1. To contribute in as many ways as possible to the welfare, prestige, and excellence of the University;
2. to promote interest in, cooperation with, and support of the University;
3. to encourage and promote a spirit of fraternity and unity among the members of the Association, and to provide means for continuing the associations which retirees enjoyed as employees of the University;
4. to represent the interests of the ~~Retirees of the University~~ members of the Association in all matters relating to the benefits accruing to ~~Retirees~~ the members; and
5. to foster an understanding of the functions of the Association among employees of the University who are nearing retirement age.

The term “Retirees of the University” has been changed to “members of the Association” because MURA aims to represent the interests of those who have retired from McMaster, those who receive a McMaster pension but are not McMaster retirees, and the spouses of McMaster employees and retirees who receive McMaster pensions due to the death of the latter.

#### Article 3.02 – Regular Members \_\_\_\_\_

~~Any person who has retired from McMaster University, who, while in the employ of the University, was eligible to become a member of a University pension plan, and whose date of retirement from the University would have qualified that person to receive a pension from that plan.~~

This is just a change for clarification. The wording being deleted obscures the intended meaning, which is that all McMaster retirees are deemed to be regular members of MURA whether or not they receive a McMaster pension. Thus, retirees who transfer their pensions out of the McMaster plan at or after retirement would still be

represented by MURA, as would employees who retire without a pension.

#### Article 3.03 – Associate Members \_\_\_\_\_

- (a) Any person who is the spouse of a regular member.
- (b) Any person who is the surviving spouse of a former Regular Member.
- (c) Any person who is the surviving spouse of an active employee, when that survivor receives a McMaster pension.
- (d) Any person who leaves the employ of the University before retirement, when that person receives a McMaster pension.
- (e) The holder of a pension from another University on whom Council has bestowed Associate membership.

Two new sections have been added to clarify intent and also to bring the definition in line with the current interpretation. MURA not only represents the interests of retirees, but also the interests of all those who receive a pension and other retirement benefits from the University. Not to include all McMaster pensioners in our organization might weaken the position of the Association in discussions or negotiations on pension and benefit matters.

#### Article 3.05 – Membership Status

~~Any member who pays the annual Active Fee shall be designated as Active for that year~~

- ~~1. Non fee-paying Members shall be designated as Inactive.~~
- ~~2. New regular members shall be designated as Active without payment of the annual fee until the end of the calendar year following the calendar year of their retirement~~

These categories of membership status are not required. MUSA members no longer pay membership dues because of the Association’s new funding arrangements with the University, the Faculty Association and MUSA. Membership services and privileges will now be defined according to membership type—Regular, Associate and Honorary.

In addition, because of these new financial arrangements, the term “regular active members” has been replaced with “regular members” throughout the Constitution.

#### Article 5.12 – Committees \_\_\_\_\_

~~The Council may establish such committees and shall appoint the chair and members thereof as it deems necessary to carry out the affairs of the Association. Such committees shall be responsible to the Council and the Council shall establish their terms of reference, duties, powers and duration, by resolution or by by-law. The Council in each year shall establish those standing committees set forth in Article 7 of this Constitution.~~

This article is being deleted because its content has been included in Article 7.02.

Article 6.02 - Other Officers

~~From time to time the Council may appoint such other officers as it determines. The Council shall appoint a Secretary and a Treasurer annually, not necessarily from among the elected members of Council, and may appoint such other officers as it deems necessary for the proper functioning of the Council.~~

This article has been revised to be somewhat more specific about the appointment of officers and to reflect what has been the practice for some years.

Article 7 - Committees

**7.01 Standing Committees The Nominating Committee**

~~The Council shall establish a Nominating Committee each year, consisting of the Past President of the Association, who shall act as chair, and four other regular members of the Association appointed by Council, two of whom shall not be members of the Council. The terms of reference of the Nominating Committee are described in Article 8 below.~~

~~Subject to Article 8 hereof, the Council shall establish at its first meeting in each year the following standing committees and shall appoint a chair thereof upon the recommendation of the Executive Committee~~

- 1 Services
- 2 Social
- 3 Nominating, subject to Article 8 hereof
- 4 Membership

~~The terms of reference, duties and powers of these committees shall be established from time to time by resolution or by by-laws of the Council.~~

**7.02 Special Committees Other Standing and Special Committees**

~~The Council may appoint such other committees and assign such duties and powers to such committees as the Council or Executive Committee deems advisable.~~

~~The Council may establish such other standing and special committees as it deems necessary to carry out the business of the Association. Such committees shall be responsible to the Council and their composition and terms of reference shall be approved by resolution of the Council. The Council shall appoint the members of all standing committees normally at either the September or October meeting of Council following the Annual General Meeting~~

Article 7 has been revised to include the Nominating Committee in the Committees section of the Constitution (rather than the Elections section) and to leave the Council with total flexibility to establish other committees, either standing or special. In this way, committees can be set up from time to time to meet specific needs, without requiring

changes to the Constitution.

Article 8.02 - Nominating Committee

~~The nominating committee shall consist of the Past President of the Association, who shall act as chair, and four (4) other regular active members of the Association appointed by Council, two of whom shall not be members of the Council.~~

This article has been deleted because its content has been included in Article 7.01.

Article 9.01 - Official Publication

**9.01 The MURAL\* MURANews (The McMaster University Retirees Association Letter News)**

The MURAL MURANews shall be the official publication of the Association. It shall be published ~~from time to time~~ periodically and a copy of each issue shall be ~~mailed~~ made available to each regular active member of the Association whose address is on file at the time of publication. all members of the Association whose address is on file, except those who have requested not to receive a copy. The Council may by resolution change the name or mode of publication of the official publication.

~~The issue of the newsletter announcing the AGM and the one reporting the outcomes of the AGM shall be sent to all Members of the Association whose address is on file, except those who have requested "no mailings". The Council may approve a general mailing of issues with information critical to all members and of overall benefit~~

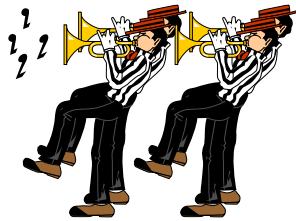

In the past, the Association's newsletter has been sent only to those Association members who had paid their dues, i.e., "regular active" members. Now that that distinction no longer exists, the article is being revised to state that the publication will be mailed to all members of the Association whose address is on file, except for those who have requested not to receive a copy.

Article 13.01 - Procedural Authority

~~The Chair of a meeting shall conduct the proceedings in conformity with the rules of procedure contained in the Constitution and, in all cases not so provided, the following reference shall be used: M. K. Kerr and H. W. King. Procedures for Meetings and Organizations. Carswell Legal Publications, 1984~~

This article has been added to correct an omission. Every constitution should specify a procedural authority to which committee chairs can refer when a procedural problem or question arises that is not covered in that constitution.
